### **SECTION 3.** Hazards Identification

## **Emergency Overview**

CAUTION! MAY CAUSE IRRITATION TO SKIN, EYES, AND RESPIRATORY TRACT. MAY AFFECT KIDNEYS. HARMFUL IF SWALLOWED OR INHALED.

## **Potential Health Effects**

### **Inhalation:**

Due to the low vapor pressure, inhalation of the vapors at room temperatures is unlikely. Inhalation of mist may cause irritation of respiratory tract. Symptoms may include coughing, shortness of breath.

### **Ingestion:**

Mild alkali. Causes irritation and reddening to the mucous membranes of the mouth, esophagus, and gastrointestinal tract. Symptoms may include nausea, vomiting and diarrhea. Large oral doses may cause weakness, collapse, blood clotting and coma. Estimated lethal dose: 50 grams of pure TRIS solid.

### **Skin Contact:**

May cause irritation.

### **Eve Contact:**

May cause irritation.

# **Chronic Exposure:**

May cause kidney injury. Chronic dermatitis may follow skin contact.

# **Aggravation of Pre-existing Conditions:**

Persons with pre-existing skin disorders or eye problems or impaired liver or kidney function may be more susceptible to the effects of the substance.

### **SECTION 4.** First Aid Measures

### **Inhalation:**

Remove to fresh air. Get medical attention for any breathing difficulty.

### **Ingestion:**

Induce vomiting immediately as directed by medical personnel. Never give anything by mouth to an unconscious person. Get medical attention.

## **Skin Contact:**

Immediately flush skin with plenty of water for at least 15 minutes. Remove contaminated clothing and shoes. Wash clothing before reuse. Thoroughly clean shoes before reuse. Get medical attention if irritation develops.

## **Eye Contact:**

Immediately flush eyes with plenty of water for at least 15 minutes, lifting upper and lower eyelids occasionally. Get medical attention if irritation persists.

# **SECTION 5.** Fire Fighting Measures

### **Explosion:**

# Fire Extinguishing Media:

Use any means suitable for extinguishing surrounding fire. Water spray, dry chemical, alcohol foam, or carbon dioxide extinguishers are effective. Water spray may be used to extinguish surrounding fire and cool exposed containers. Water spray will also reduce fume and irritant gases.

### **Special Information:**

In the event of a fire, wear full protective clothing and NIOSH-approved self-contained breathing apparatus with full facepiece operated in the pressure demand or other positive pressure mode.

#### SECTION 6. Accidental Release Measures

Ventilate area of leak or spill. Wear appropriate personal protective equipment as specified in Section 8. Contain and recover liquid when possible. Collect liquid in an appropriate container or absorb with an inert material (e. g., vermiculite, dry sand, earth), and place in a chemical waste container. Do not use combustible materials, such as saw dust. Do not flush to sewer!

## **SECTION 7. Handling and Storage**

Keep in a tightly closed container, stored in a cool, dry, ventilated area. Protect against physical damage. Isolate from incompatible substances. Containers of this material may be hazardous when empty since they retain product residues (vapors, liquid); observe all warnings and precautions listed for the product.

## **Ventilation System:**

A system of local and/or general exhaust is recommended to keep employee exposures below the Airborne Exposure Limits. ## **Personal Respirators (NIOSH Approved):**
